Application for increase in water rates in Franklin County by

## **Water Management Services, Inc.**

DOCKET NO. 110200-WU

*On November 7, 2011, Water Management Services, Inc. (WMSI) filed an application with the Florida Public Service Commission (PSC or Commission) to increase its water rates. WMSI provides water service to 1,808 customers in Franklin County.*

### **QUESTIONS & ANSWERS**

#### **1 Is there an opportunity for public input on this rate case?**

Yes. As part of the evaluation process for WMSI's rate request, the Commission will conduct two customer service hearings to allow customer feedback about WMSI and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. Commissioners will attend and participate during the customer service hearings.

#### **2 Why is WMSI requesting a rate increase?**

WMSI is requesting a rate increase to cover increasing operating costs and to pay for plant improvements.

#### **3 When was WMSI's last approved rate case?**

WMSI's last approved rate case was in December 2010, with rates taking effect in February 2011.

#### **4 Presently, how much is the monthly water bill for a residential customer using 5,000 gallons?**

Under current Commission proposed final rates, the monthly water bill for a residential customer using 5,000 gallons is \$65.88.

## 5 Using WMSI's proposed rates, how much would the monthly water bill be for a residential customer using 5,000 gallons?

Under WMSI's proposal, the monthly water bill for a residential customer using 5,000 gallons would be \$68.61.

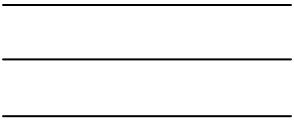
