Application for staff-assisted rate case in Polk County by **Orchid Springs Development Corporation**

DOCKET NO. 140239-WS

On December 11, 2014, Orchid Springs Development Corporation (Orchid Springs) filed an application with the Florida Public Service Commission (PSC or Commission) for a staff-assisted rate case. Orchid Springs provides service to approximately 330 water customers and 310 wastewater customers in Polk County.

QUESTIONS AND ANSWERS

1 Is there an opportunity for public input on this rate case?

Yes. As part of the evaluation process for Orchid Springs' rate request, the Commission staff will conduct a customer meeting to allow customer feedback about Orchid Springs and the rate-setting process. Customer comments, written and oral, will be taken into consideration when the Commission reaches a decision. One or more Commissioners may attend and participate during the customer meeting.

2 Why is Orchid Springs requesting a rate increase?

Orchid Springs is requesting a rate increase in order to recover the cost of operating the utility and allow the company to earn a fair rate of return on its investment.

3 When was Orchid Springs' last approved rate increase?

The utility's current rate base was last established in 1998.

4 How much are the average monthly water and wastewater bills for a residential customer using 5,000 gal-

The average monthly water and wastewater bills for a residential customer are \$18.47 and \$29.53 respectively.

5 Using the PSC staff's preliminary recommended rates, how much would the average monthly water and wastewater bills be for a residential customer using 5,000 gallons?

The average monthly water and wastewater bills for a residential customer would be \$19.00 and \$62.03 respectively.

6 What if I cannot attend the customer meeting or prefer not to speak? Are there other ways to comment on this case?
