3 Item 16.

4 Good morning, Ms. Friedrich.

5 MS. FRIEDRICH: Good morning. Marissa  
6 Friedrich speaking on behalf of Commission staff.

7 Item No. 16 addresses Wildwood Water Company's  
8 request for an increase in its rates to reflect an  
9 increase in the billing fees charged by the third-  
10 party billing company, Automated Billing Services.

11 Staff advised the utility that its request  
12 could not be addressed in a tariff filing, but  
13 rather a limited proceeding or staff-assisted rate  
14 case, since the request could impact the utility's  
15 monthly recurring base facility charge.

16 The utility verbally indicated to staff that  
17 it was not interested in pursuing either of the  
18 proceedings necessary for its original request at  
19 this time.

20 To date, the utility has not filed any  
21 additional information in relation to its original  
22 request and has been unresponsive to staff's  
23 numerous attempts in efforts to assist the utility  
24 with the appropriate proceeding.

25 Staff does not have the authority to close the

1 docket administratively without the petitioner's  
2 consent; therefore, staff is recommending that this  
3 docket be closed because no further action is  
4 required. Staff is prepared to answer any  
5 questions at this time.

6 THE CHAIRMAN: Commissioners, any questions on  
7 this? Seeing none --

8 COMMISSIONER BRISÉ: Move staff.

9 COMMISSIONER GRAHAM: Second.

10 THE CHAIRMAN: Any discussion?
