NOTICE OF PROPOSED AGENCY ACTION ORDER GRANTING APPLICATION FOR CERTIFICATE OF AUTHORITY TO PROVIDE TELECOMMUNICATIONS SERVICE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code (F.A.C.).

Peak Tower, LLC applied for a Certificate of Authority to provide telecommunications service, pursuant to Section 364.335, Florida Statutes (F.S.). Upon review of the application, it appears that Peak Tower, LLC has sufficient technical, financial, and managerial capability to provide such service. Accordingly, we hereby grant to Peak Tower, LLC Certificate of Authority No. 8919, which shall authorize Peak Tower, LLC to provide telecommunications service throughout the State of Florida.

Telecommunications service providers are required to comply with all applicable provisions of Chapter 364, F.S., and Chapter 25-4, F.A.C.

In addition, under Section 364.336, F.S., certificate holders must pay a minimum annual Regulatory Assessment Fee (RAF) if the certificate was active during any portion of the calendar year. A RAF Return notice will be mailed each December to Peak Tower, LLC for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAF Return notice shall relieve Peak Tower, LLC from its obligation to pay its RAF.

If this Order becomes final and effective, it will serve as Peak Tower, LLC's certificate. Peak Tower, LLC shall retain this Order as proof of its certification. We are vested with jurisdiction over this matter pursuant to Sections 364.335 and 364.336, F.S.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Peak Tower, LLC's application for a Certificate of Authority is hereby granted. It is further

ORDERED that Peak Tower, LLC is awarded Certificate of Authority No. 8919, which authorizes Peak Tower, LLC to provide telecommunications service throughout the State of Florida, subject to the terms and conditions set forth in the body of this Order. It is further

ORDERED that this Order shall serve as Peak Tower, LLC's certificate and shall be retained by Peak Tower, LLC as proof of certification. It is further

ORDERED that the provisions of this Order, issued as a proposed agency action, shall become final and effective upon the issuance of a Consummating Order unless an appropriate petition, in the form provided by Rule 28-106.201, Florida Administrative Code, is received by the Commission Clerk, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on the date set forth in the "Notice of Further Proceedings" attached hereto. It is further

ORDERED that in the event this Order becomes final, this docket shall be closed.
