2 CHAIRMAN GRAHAM: Item No. 7.

3 MR. DOHERTY: Good morning Commissioners.

4 Riley Doherty with Commission staff.

5 Item 7 is a proposed arrangement between Tampa  
6 Electric Company and MacDill Air Force Base for the  
7 application of totalized metering, which is  
8 summation of adjacent metering equipment readings  
9 serving the same property.

10 Under the totalized metering arrangement  
11 MacDill will pay one customer charge in the  
12 kilowatt hours metered at the two substations will  
13 be added together. The demand billed will be the  
14 highest, total highest or combined demand  
15 registered at both substations.

16 Staff has reviewed TECO and MacDill's proposed  
17 arrangement or special contract and data provided  
18 during the informal meeting on Tuesday, May 1st,  
19 2018. Staff believes the proposed arrangement  
20 between TECO and MacDill is reasonable and  
21 recommend Commission approval.
