**FLORIDA POWER & LIGHT COMPANY'S NOTICE WITHDRAWAL
OF REQUEST FOR CONFIDENTIAL CLASSIFICATION**

Florida Power & Light Company ("FPL") hereby gives notice of its withdrawal of its Request for Confidential Classification (Document No. 06351-2018) filed on October 1, 2018. The request was originally filed to protect information included in FPL's response to Interrogatory No. 5 of the Office of Public Counsel's ("OPC") First Set of Interrogatories (Nos. 1-7). FPL has now served an amended response to OPC Interrogatory No. 5, which replaces FPL's original response served October 1, 2018. Unlike FPL's original response to OPC Interrogatory No. 5, FPL does not seek any confidential treatment of the amended response. OPC and the Staff of the Public Service Commission are agreeable to using FPL's amended response to OPC Interrogatory No. 5 in the place of the original response and OPC has returned the previously served response to FPL. Therefore, FPL hereby withdraws its Request for Confidential Classification (Document No. 06351-2018).
