COMES NOW, BellSouth Telecommunications, Inc. d/b/a Southern Bell Telephone and Telegraph Company ("Southern Bell" or "Company"), and pursuant to Rule 25.22.006, Florida Administrative Code, files its Notice of Intent to Request Confidential Classification.

1. The Staff of the Florida Public Service Commission ("Staff") has issued several Audit Requests in connection with the NARUC/FCC Regional Audit of BellSouth. Staff has requested, among other things, that Southern Bell furnish the following information:

2. Audit Request No. 2-175, dated October 7, 1993 - requests information concerning project billing versus FDC calculation for Treasury projects.

Audit Request No. 2-176, dated October 7, 1993 - requests information concerning project billing versus FDC calculation for AVP and comptroller projects, Parts A & B.

Audit Request No. 2-177, dated October 7, 1993 - requests information concerning project billing versus FDC calculation for Human Resources projects.

Audit Request No. 5-053, dated August 11, 1993 - a copy of all organization studies affecting BellSouth Telecommunications

in the last five years.

3. Some of the information being provided is clearly proprietary. For example, the information being provided contains financial and strategic information relating to non-regulated affiliates, vendor specific information and reviews of internal operations. Such information is specifically considered to be proprietary, confidential business information pursuant to § 364.183(3)(e) and (f), Florida Statutes.

4. Consequently, because this information contains proprietary information, Southern Bell is filing this Notice of Intent to Request Confidential Classification, pursuant to Rule 25-22.006(3)(a), Florida Administrative Code, in order to allow the Staff to review this information without delay. Both the original of this notice and the individual requests have been filed with the Division of Records and Reporting, and a copy has been served on the Division requesting the information. The written Staff Requests are not attached hereto, with the exception of Item Nos. 2-177 and 5-053, due to the fact that the requests themselves contain proprietary information.
