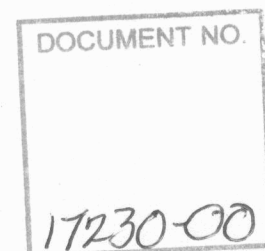

The purpose of this letter is to warn you of the great disaster it would be for our family if you changed our telephone exchange from Mount Dora to Apopka, so calls to Lake county became toll calls for us. We live about 100 feet into Orange County from the Lake-Orange County line. You can almost throw a baseball into Lake county from our yard. The town of Mount Dora borders on the County line right across from our house.

It is a technicality that we happen to live in Orange county. Our social and business activities and the focus of our lives is in Lake County. Our inconvenience and added expense of phoning long distance to friends a block away or relatives a mile away would be multiplied many times when our friends and relatives would have to phone long distance to talk to us. It would be a bonanza for the phone company. Also, the stores and businesses we use in Lake County will not return our calls if they have to phone long distance...we would become outcasts to them.

We feel so strongly about our need to stay in the Mount Dora exchange that we have talked to neighbors about filing a class action law suit if necessary. Almost all of them feel the same way we do, and some have said they would join us in the class action litigation, so we have had preliminary discussions with an attorney.

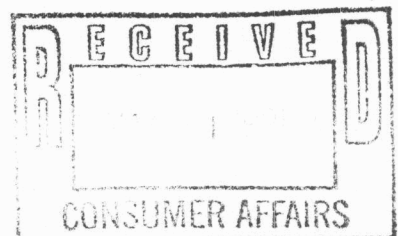
We pray that you will continue to use the good judgement you have shown so far in this matter and will let us stay in the Mount Dora exchange.

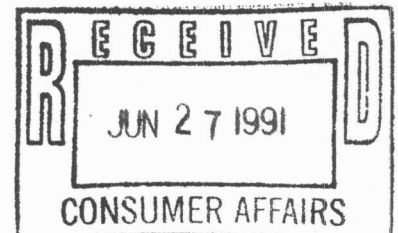

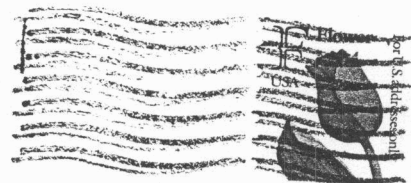

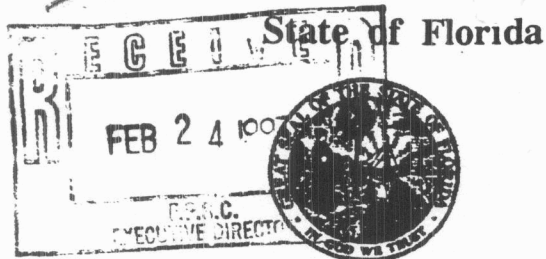
