Mr. Talbott asked me to respond to your April 25 letter concerning extended area service (EAS) in Palm Beach County and our recent decision on the Broward-Dade routes. I hope I can provide you with additional information to clarify the two dockets.

The Broward-Dade case started in 1991 when the Broward Board of County Commissioners requested extended area service (EAS) between Fort Lauderdale, Hollywood, North Dade, and Miami. In other words, the county commissioners requested flat-rate, nonoptional, 2-way EAS between the four exchanges. After Southern Bell conducted traffic studies, the Commission denied flat-rate EAS because the calling rates did not meet our rule requirement, a copy of which is attached.

After Hurricane Andrew's destruction in Dade County, residents from Fort Lauderdale/Hollywood advised us that their calling patterns had changed substantially. These customers indicated that with the influx of new residents into the Fort Lauderdale/Hollywood area, increased calling to the Miami area was substantial because a majority of the newcomers worked in Dade County. Therefore, the Commission ordered new traffic studies and ordered that the hybrid  $25 \, \text{¢}$  plan ( $25 \, \text{¢}$  for residences;  $10 \, \text{¢}$  for 1st minute and  $6 \, \text{¢}$  for additional minutes for businesses) be implemented while the traffic studies were being conducted and analyzed.

The Florida Interexchange Carriers Association protested the Commission's decision. Therefore, the hybrid plan was not implemented until hearings could be held. Also, this docket was incorporated into the Southern Bell rate review case due to the complexities of the issues involved. In January, a settlement was reached in the Southern Bell case between all parties, which was approved by this Commission, and, in part, the stipulation called for a "reduction of \$11 million for expanded local calling between Broward and Dade counties."

On April 19, 1994, the Commission again approved the hybrid 25¢ plan which is scheduled for implementation January 23, 1995. The long distance carriers may continue to carry the calls on these routes and compete with Southern Bell. You are correct that the customers involved were not balloted in this case due to the extenuating circumstances.

The Palm Beach County EAS docket was opened after we received a resolution from the Palm Beach County Commissioners requesting flat-rate local calling between all exchanges in Palm Beach County. The Commission ordered traffic studies. Of the routes studied, only the Belle Glade to West Palm Beach, Boca Raton to West Palm Beach, and Pahokee to West Palm Beach had calling volumes and distribution significant to meet our EAS rules. The Delray Beach to West Palm Beach and Boynton Beach to Boca Raton routes were also included to avoid leapfrogging (having toll routes in between routes that can call toll-free). Therefore, the Commission ordered that the customers of Belle Glade, Boca Raton, Delray Beach, and Pahokee be balloted to determine if they are in favor of paying a monthly additive to call the West Palm Beach exchange toll-free. Also, Boynton Beach customers will be balloted for toll-free calling to Boca Raton. After the ballots are received and analyzed, the Commission is tentatively scheduled to make a decision on these routes August 2, 1994.

I'm placing a copy of your letter in the docket file of the Palm Beach County EAS case so your comments will be available for review by everyone. If you have any questions, please let me know.

Dear Mr. Talbott:

I wanted to express my concern over the forthcoming mailing and public referendum being conducted by Southern Bell under your auspices, which will seek to ascertain whether or not the public wants to have some sort of fixed rate telephone service in Palm Beach County.

Residential customers have a completely different interest than business customers in this regard. It is quite likely that resident customers (many of whom are retired) will not want a fixed rate system, since they do not make many calls which necessitate a "1" before dialing. Certainly, they do not make nearly the number of calls that a business does in any given day. On the other hand, a business in Boca Raton, for example, will want such a fixed rate system.

It appears to be quite unfortunate that you have allowed Southern Bell to proceed in this manner. I simply do not understand why Southern Bell is not forced to institute a fixed rate system, as is the case in Broward County and Dade County. There was never a public referendum in those counties in this regard.

Please let me hear from you concerning this matter, as it appears that this action may very well shortchange the business community in Palm Beach County.

Thank you for your letter of August 19, 1995, in support of reducing long distance rates on routes within Palm Beach County.

At its August 15, 1995, agenda conference, the Florida Public Service Commission ordered Southern Bell to provide extended calling service (ECS) on several routes within Palm Beach County. ECS rates residential calls at \$.25 per call regardless of duration. Business calls are rated at \$.10 for the first minute and \$.06 for each additional minute. West Palm Beach to Delray Beach and West Palm Beach to Boca Raton were two of the routes that were approved. The Commission has ordered Southern Bell to implement these routes as soon as possible, but no later than March 12, 1996.


