Unlike many of their new neighbors, Guy and Jan McPherson didn't move to Polk City for its access to Tampa and Orlando.

Tuesday, August 10, 1993

"It's a quiet area and people take pride in it, which makes it really nice," said Guy McPherson, 68, who moved to Polk City a year ago from north of Fort Wayne, Ind. "We were just driving around and saw a nice little community."

But even McPherson, now Polk City's part-... code enforcement officer, has discovered the community's prime attraction.

"I can go two hours, and I hit water. That's kind of nice," McPherson said. "I'm not too far away from anything."

Polk City and other communities that can make similar claims are growing quickly as commuters discover the relatively short drives they face to Orlando, Tampa and Walt Disney World.

An indicator of this activity is telephone hookups.

According to GTE Florida and United Telephone of Florida, the four areas encompassing Loughman-Baseball City, Polk City, Poinciana and north Lakeland are showing the fastest growth in commercial and residential telephone hookups among Polk County's 23

calling regions.

Hookups in the Loughman-Baseball City area, which includes a 10,000-acre countydefined growth area between U.S. 17-92 and U.S. 27, grew from 3,865 in October 1991 to 4,421 in October 1992, a rise of 14.4 percent.

The Polk City area, which includes most of the county's central and eastern portions of the Green Swamp, grew from 3,201 to 3,517 hookups, an increase of 9.9 percent.

Polk County's portion of Poinciana, an unincorporated community east of Haines City, grew from 1,101 to 1,209 hookups, a gain of 9.8 percent.

North Lakeland, including western Polk County north of Interstate 4, grew from 18,952 to 20,297 hookups, an increase of 7.1 percent.


The Lake Alfred area saw the slowest hookup growth, from 4,155 to 4,196 — a gain of just 1.0 percent.

As expected, the growth is not without debate.

Chuck Geanangel, a Lake Alfred resident who founded Friends of the Green Swamp, would like to see the fast growing areas of the county revert to the slow growth of his community.

The growth in Polk City and north Lakeland, he points out, is primarily in the Green


