



As a taxpayer of DeSoto County and as President of Kingsway Country Club, I am concerned about the recent agreement made between Lake Suzy Utilities and the Charlotte County Board of Commissioners. This agreement grants permission for Lake Suzy Utilities to extend water service from DeSoto County to residents of Charlotte County, specifically to the 49 platted lots of the Links development. Sewer service to the Links development is to be provided by Charlotte County.

I feel this agreement is detrimental to DeSoto County and its taxpayers, as the County would lose control of regulating the water rates and would lose the ability to franchise new service areas. DeSoto County should have control of those factors that are important to growth and development within the County.

The increased legal and administrative costs for Lake Suzy Utilities, which would be regulated by the Public Service Commission, would be out of proportion to the monetary benefits derived by Lake Suzy Utilities for extending service to such a small area. The increased costs would have to be passed on to the residents of DeSoto County, who are customers of Lake Suzy Utilities.

Charlotte County is in a position to provide water and sewage service to the Links development and there is no need for Lake Suzy Utilities to extend service across the county line.




