REPORT OF THE PARTIES

Pursuant to Federal Rule of Civil Procedure 26(f) and this Court's initial scheduling order, attorneys for the parties held a conference call on December 8, 2000, attended by:

Wesley R. Parsons and Sean Lev on behalf of BellSouth Telecommunications, Inc. ("BellSouth")

Jon C. Moyle, Jr. and Christopher W. Savage on behalf of Global NAPS, Inc. ("Global NAPS")

Martha Carter Brown

on behalf of the Florida Public Service Commission (the "PSC") and the Commissioners of the PSC

At that meeting, the parties agreed to request that the Court revise the initial scheduling order by adopting the following procedure and schedule:

1. Nature of Proceeding. Pursuant to 47 U.S.C. § 252(e), the Court is sitting in review of decisions of the PSC under the Telecommunications Act of 1996. The specific issue under review is whether BellSouth is required to pay reciprocal compensation on Internet-bound traffic that it hands off to Global NAPS under the terms of the interconnection agreement at issue.

BellSouth v. Global NAPS

Civil Action No. 4:00-CV-353-RH

- 2. <u>Possibility of Settlement</u>. The parties agree that settlement is possible, but that mediation under the circumstances of this case would not be helpful in resolving the issues in dispute.
- 3. Revisions to Initial Scheduling Order. The parties agree that due to the nature of these proceedings, the Court should adopt an appellate-style briefing schedule with an opportunity for oral argument. Accordingly, the parties request that the Court adjust the initial scheduling order as follows:
 - a. BellSouth's initial brief shall be served by February 2, 2001.
 - b. Defendants' answer briefs shall be served by March 2, 2001.
 - c. BellSouth's reply brief shall be served by March 23, 2001.
 - d. If the PSC argues the issue of Eleventh Amendment immunity in its answer brief, Global NAPS may serve a reply brief addressing only such issue by March 23, 2001.

The parties have further agreed to a 50-page limit for initial and answer briefs, and a 35-page limit for the reply brief. An appellate-style briefing schedule has been used by this Court in this type of case before. See BellSouth Telecommunications, Inc. v. AT&T Communications of the Southern States, Inc., Civil Action No. 4:99-CV-448-RH (Order of March 6, 2000); BellSouth Telecommunications, Inc. v. MCImetro Access Transmission Services, LLC, Civil Action No. 4:99-CV-450-RH (Order of March 6, 2000).

4. <u>Discovery Requirements</u>. The parties agree that no discovery is required and that review in this Court should be limited to the record below and argument of counsel. The parties stipulate that disclosures pursuant to Federal Rules of Civil Procedure 26(a)(1) and 26(a)(2) are not required.

- 5. Trial. The parties agree that no trial is necessary, and that the Court should decide this matter on the pleadings and record in this action, the briefs of the parties, and argument of counsel. The parties further agree that oral argument is necessary for a fair determination of the issues. Finally, the parties request that oral argument be set as soon after March 23, 2001, as the Court's calendar permits.
- 6. Record on Appeal. The parties agree that the entire record below shall be transmitted to the Court. The clerk of the PSC shall provide the parties with an index to the record on appeal by January 19, 2001. The parties agree that the record to be submitted to the Court in this case includes the record before the PSC in Docket No. 991267-TP. The parties reserve the right to make supplemental designations to the materials filed in this docket.
- 7. Manual for Complex Litigation. The parties agree that this matter should not be made subject to the Manual for Complex Litigation.
