All recommended denials were because the information did not appear to relate to competitive financial strategies and interests, the disclosure of which would impair the competitive business of FPL Group and its subsidiaries.

Page 43 of the company's request contains a reference to page 002014 of the POD. No such page exists so a recommendation cannot be made on it. I believe that the above requests and denials address every occurrence of proposed confidential information in the POD submission, so notwithstanding the reference to page 002014, the recommendation is complete.
