Ray, on 1/10/02, the Commission received this company's 2001 RAF return form, but no money was included. The company had "Out of service" handwritten on the form.

On 1/17/02, I wrote the president, Mr. Douglas Oesterle, a letter and stated that the Commission had received the form "with what appears to be a request for cancellation." I attached the same form that was written on and explained that in order to grant a voluntary cancellation, the company would need to pay the 2001 RAF. My letter stated "Once the 2001 RAF is paid (due by January 30, 2002), then the Commission will voluntarily cancel the certificate with an effective date of December 31, 2001."

The company paid the 2001 RAF on 2/5/02. There was no letter or other note indicating the company did not want his certificate cancelled, nor did I receive a phone call in response to my letter; therefore, I forwarded the voluntary cancellation on to Jackie Gilchrist's section. The final Order was issued 3/5/02 (not a PAA).

I have no idea who Mr. Gonzalez is. He is not the liaison and I've had no dealings with him. Is there anything I should do?
