On March 12, 2002, Docket No. 020224-TP was established to address Convergent Communications Services, Inc.'s cancellation of Interexchange Telecommunications (IXC) Certificate No. 5723 and Alternative Local Exchange Telecommunications (ALEC) Certificate No. 7266 due to bankruptcy. By Order No. PSC-02-0507-PAA-TP, issued on April 12, 2002, the Commission approved the cancellation of Convergent Communications Services, Inc.'s IXC Certificate No. 5723 and ALEC Certificate No. 7266. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the years 2001 and 2002 for TJ162 and TX378.
