**SUPPLEMENT TO
JOINT PETITION FOR APPROVAL OF TERRITORIAL AGREEMENT**

Clay Electric Cooperative, Inc., a not-for-profit corporation, ("Clay") and the City of Gainesville, Florida, a municipal corporation, d/b/a Gainesville Regional Utilities ("GRU"), submit herewith as a supplement to their Joint Petition a report on the response from customers of the two utilities with respect to the transfer, an updated list of the customers being transferred showing their rate classification, and the parties agreement to certain changes requested by the Staff of the Commission. Hence, attached hereto as Exhibit "A" is a list of customers who have contacted Clay as of April 8, 2002, in reference to the Territorial Agreement. All of the customers listed on Exhibit "A" (numbers 1 – 14) have advised Clay that they do not want to be transferred. Exhibit "B", attached hereto, represents responses that GRU has received with respect to the Territorial Agreement. Exhibit "C", attached hereto, is a listing of Clay's customers to be transferred to GRU, with their rate classification. Exhibit "D", attached hereto, is a listing of GRU's customers to be transferred to Clay with their rate classification.

The following represents the parties' joint response to concerns of the Staff of the Commission relating to the terms and conditions of the agreement:

1. Interim service referred in 2.4 is subject to the three-year limitation of Section 3.3. The parties intend that there be only one transfer, that is, when they are ready to transfer customers it will all be done at once.
2. The parties are agreeable to filing annual reports as to the status of interim services.
3. In Section 3.2, the parties have no objection to amending the word "purchase" to the word "acquire" so that, in Sub-Section A, it would read: "In the event either party elects to acquire a customer or service facilities..."
4. In Section 3.3, the parties have no objection to changing the word "acquisition" to the word "transfer" so that the last sentence will read: "Such action will result in the transfer of the customers and service facilities..."
5. The parties are agreeable to filing annual reports as to the status of completion of transfers.
6. The parties are agreeable to filing annual reports as to the status of GRU's removal of facilities along Williston Road and Archer Road.
7. Regarding the Staff's questions about customer deposits and capital credits, both utilities will handle customer deposits in the same fashion as all other

customers of each utility. Hence, when a customer leaves the utility system the customer's deposit will be refunded in accordance with that utility's policies. The customers being transferred to a utility will be subject to that utility's deposit requirements. If they had not been required to post a deposit for one of the utilities, it is likely that they would not be required to post one to the utility that they are being transferred to: Regarding Clay's capital credits, those are the property of the customer and will remain the property of the customer notwithstanding the transfer.

8. Regarding Staff's concern about Section 4.4 and what the Section was intended to address, the parties deem it is critical to the agreement that any facilities that they have constructed to serve customers that are not being transferred and which facilities, therefore, remain useful in serving customers shall remain in place and would not be subject to being removed. The fact that such facilities may be in the other party's territorial area do not constitute a violation of the agreement.

9. Section 4.5 is meant to address facilities that each utility itself owns and operates. Hence, each is entitled to provide service to its own facilities where the providing of such service is feasible and does not interfere or hinder the other party from serving other customers. For example, GRU will be providing water and sewer services in the electric service area of Clay in many instances and may provide electric service to

its own facilities, such as lift stations and pumping stations.

10. With respect to Section 5.2 relating to franchises, this Section is important to both parties with respect to franchise agreements that either party may have or may be granted by other municipalities in Alachua County. Hence, if the City of Newberry, which currently receives electric service from Florida Power Corporation, were to grant GRU a franchise, or if the City of Newberry granted Clay a franchise, neither instance would constitute a violation of this agreement.

11. Regarding Section 5.3, this Section is need to allow the parties to address fundamental changes that might be adopted by the Florida Legislature with respect to retail deregulation. It is not necessary to define it or to discuss it in any further detail than to simply provide that in the event the State of Florida does adopt some form of retail deregulation, regardless of how it is defined, the parties are acknowledging that they may come back before the Commission for a modification of this agreement.

12. Section 6.1 refers to a deadline of August 1, 2002 for approval by the Commission. The parties hereby agree to eliminate the sentence that reads: "If formal approval is not received on or before August 1, 2002, each of the parties hereto may be released from the effect thereof and any and all obligations hereunder unless agreed by the parties."


This Stipulation constitutes an agreement between the parties on the matters stated herein, supplementing the Territorial Agreement previously filed in this docket.

13. In addition to the foregoing joint response to staff concerns, the parties hereby advise the Commission that on April 22, 2002, the City Commission of the City of Gainesville adopted Ordinance No. 001839 which amended, effective June 1, 2002, the electric rates of the City, thereby affecting the rates that will be applicable to customers subject to the transfers contemplated by the proposed Territorial Agreement. Copies of letters by the parties to their respective customers advising them of these rate revisions are attached hereto as Exhibit E. The parties agree to advise the Commission regarding customer comments that may be received as a consequence of this additional notice to affected customers.

Dear Mr. Jones,

Please find enclosed a table outlining a comparison of residential electric rates charged by GRU and Clay Electric Cooperative. This table also includes hypothetical bill calculations for usage levels of 500 kWh per month through 2500 kWh per month. Usage for your account has ranged from about 1000 kWh per month to 2500 kWh per month over the last year.

Fuel adjustments for both GRU and Clay Electric can vary monthly, and the actual fuel adjustment from each company for March 2002 was used in these comparisons.

The bottom line is that bills from Clay Electric for the same amount of electrical usage will be slightly lower than those from GRU. One factor contributing to this difference is the surcharge collected for the City of Gainesville on the GRU bill is not on the Clay Electric bill.

Hi Mr. Jones!

Sorry for the delay in responding to your last e-mail. I will have someone on staff prepare sample bills using both Clay Electric and GRU rates so that their effect on a typical monthly bill will be clear. We should be able to get that information to you by early next week. I will have the information mailed to your billing address. However, if there is another address that would be more appropriate, please let me know.

With regard to your observation on customer choice in the construction of Territorial Agreements, you are correct to a point. The utilities look for a logical operational break point between the two utilities to reduce, or avoid the installation of, duplicate infrastructure. They also project their abilities to serve new and existing customers in various operational areas and propose boundary adjustments accordingly. To this point customers have not been made part of this decision making process for it is largely technical or operational in nature. However, the Florida Public Service Commission (FPSC) does require GRU and Clay Electric to submit customer feedback regarding the proposed Territorial Agreement. Your correspondence to GRU will be part of the record presented to the FPSC. They do take all information presented into consideration when reviewing the territorial proposal.

I wish to assure you that we do listen to our customers' comments and if their issues or preferences can be reasonably accommodated, I think both utilities would make such an adjustment. In your situation however, GRU would have to maintain a fairly long expanse of line and perpetuate the duplication of infrastructure along that segment of Archer Rd. Such action would largely undermine the purpose of the proposed Agreement.

Dear Mr. Jones,

Thank you for your email and feedback regarding the proposed Clay Electric / GRU Territorial Agreement. We are very pleased to hear that you have found our service to be so reliable and that you would prefer to remain our customer. It is with significant regret that both utilities face the prospect of transferring valued customers to the other utility. I can assure you that such action has not been taken lightly.

As you probably are aware both Clay Electric and GRU have many facilities along the Archer Rd. corridor, west of I-75. Many of these facilities serve duplicate functions. One of the primary goals of our proposed Agreement is to reduce the presence of power distribution facilities that clutter this roadway. The reduction of duplicate infrastructure, and associated operating and maintenance costs, will benefit all customers for it helps to reduce our costs. This goal is in keeping with long standing principles championed by the Florida Public Service Commission.

At present GRU does own, operate, and maintain the distribution line that runs adjacent to your property. Clay Electric's distribution line in that area runs along the north side of Archer Rd. Under the terms of the proposed Agreement Clay will acquire GRU's facilities along this stretch of roadway in order for them to serve you, your neighbors, and any new customers in that area. Clay may elect to rebuild parts of the line and remove the elements that they do not need. Although I wouldn't expect or anticipate any need for them to build a second line adjacent to your property, Clay will likely complete a detailed engineering study to determine how they will serve all customers in that area and which facilities will serve those customers best.

With respect to your electric bills, Clay Electric and GRU have very competitive residential service rates. In fact, if the proposed customer transfer where to take place immediately (**which it will not**), it is most likely that you would pay slightly less for electric service provided by Clay than you now. Certainly rates may change over the course of the next year or longer, however, Clay and GRU's rates are very likely to remain very competitive and close. If you would like some assistance in computing a typical monthly bill using both rates, I'd be very willing to work with you on it.

In closing, Clay Electric and GRU both believe that the proposed Agreement will significantly benefit the greater Gainesville community in the form of lower energy delivery costs, reduced infrastructure clutter, and lineworker safety. Although we would prefer not to loose you as a customer, we take comfort in knowing that you will be placed in good hands. If you should have any additional comments or questions, please feel free to contact me.

In a letter dated February 21, 2002 we notified you that your cooperative had entered into a new territorial agreement with Gainesville Regional Utilities (GRU) and that your electric service would be transferred to GRU within three years of the agreement's approval date by the Florida Public Service Commission.

The purpose of this letter is to update the rate chart that was included in the notification letter of February 21. This revised chart reflects recently approved GRU rate changes that provide overall rate reductions for GRU customers effective June 1, 2002. It also remedies an error in the rate structure occurring in the original chart provided by GRU.

As noted in the original notification letter of February 21, the new agreement has been approved by both utilities. The agreement has been sent to the Florida Public Service Commission (PSC). If approved by the PSC, there will be approximately 1100 Clay Electric accounts southwest of Gainesville (Archer Road area - west of I75) that will be transferred to GRU (within three years of approval by the PSC). GRU customers located in Savannah Pointe (Williston Road - west of I75) will be transferred to Clay Electric.

You were previously notified that Gainesville Regional Utilities (GRU) and Clay Electric have entered into a new territorial agreement. The agreement has been approved by both utilities and is currently being reviewed by the Florida Public Service Commission (PSC). Your electric account is among approximately 20 GRU accounts in the southwest Gainesville area (Savannah Pointe, Williston Rd.-west of I75 and south of Archer Rd., west of 63 Blvd.) that will be transferred to Clay Electric as a result of the new agreement. Transfer will occur within three years of the PSC approval date.

Included in your initial notification was a chart that outlined the rates of both Clay Electric and GRU. I apologize, but the chart incorrectly indicated that GRU's residential kilowatt-hour (kWh) charge changed at 1,000 kWh instead of at 750 kWh as it should have. Since that time, the Gainesville City Commission has approved Ordinance No. 001839 which provided overall rate reductions for GRU customers effective June 1, 2002. The new rates are summarized in the attached chart for your review. These rates supersede any previously transmitted to you.
