
**PETITION OF VERIZON FLORIDA INC. FOR APPROVAL OF

(Verizon) (formerly GTE Florida Incorporated) files this petition before the Florida Public Service Commission (Commission) seeking approval of Amendment No. 1 to the interconnection agreement with Source One Communications, Inc. d/b/a Quick Connects (Source One). In support of this petition, Verizon states:

The Verizon/Source One interconnection agreement was approved by the Commission by Order No. PSC-00-2219-FOF-TP issued November 21, 2000 in Docket No. 001235-TP. The attached amendment adopts the reciprocal compensation plan put forth in the Order on Remand and Report and Order, *In the Matter of Implementation of the Local Competition Provisions in the Telecommunications Act of 1996, Intercarrier Compensation for ISP Bound Traffic*, FCC 01-131, CC Docket Nos. 96-98 and 99-68.



The Parties' rights and obligations with respect to any intercarrier compensation that may be due in connection with their exchange of Internet traffic shall be governed by the Order on Remand and Report and Order, *In the Matter of Implementation of the Local Competition Provisions in the Telecommunications Act of 1996, Intercarrier Compensation for ISP Bound Traffic*, FCC 01-131, CC Docket Nos. 96-98 and 99-68.




