#### CASE BACKGROUND

By petition filed on May 3, 2002, Florida Power & Light Company ("FPL"), requested a declaratory statement pursuant to Section 120.565, Florida Statutes, and Rule 28-105.002, Florida Administrative Code. FPL asks the Commission to declare that it may pay a Qualifying Facility (QF) for purchase of renewable energy, an amount representing FPL's full avoided cost plus a premium borne by customers voluntarily participating in FPL's Green Energy Project. Notice of the petition was published in the Florida Administrative Weekly on May 24, 2002. New Hope Power Partnership and Palm Beach Power Corp. filed a petition to
