**Motion for Extension of Time to File Response to FPL's Motion to Dismiss**

Petitioners pursuant to Rule 28-106.204 of the Florida Administrative Code, hereby moves for an extension of time for the Petitioners to file their Response to FPL's Motion to Dismiss.

1. Petitioners filed a Petition for a Hearing on June 28, 2002.
2. FPL filed a Motion to Dismiss Complainants' Petition for a Hearing on Order No. PSC-02-0788-PAA-EI dated July 16, 2002. This motion was recorded by the Division of the Commission Clerk and Administrative Services on July 17, 2002.
3.
