

**BELLSOUTH TELECOMMUNICATIONS, INC.'S  
REQUEST FOR SPECIFIED CONFIDENTIAL CLASSIFICATION**

BellSouth Telecommunications, Inc. ("BellSouth"), hereby files, pursuant to Rule 25-22.006, Florida Administrative Code, its Request For Specified Confidential Classification and states the following:

1. On July 8, 2002, Supra Telecommunications & Information Systems, Inc. ("Supra") filed its Motion to Stay Commission Order Nos. 0413 and 0878 Pending Appeal Pursuant to Rule 25-22.061, F.A.C.
2. On July 12, 2002, BellSouth filed its Opposition to Supra's Motion to Stay Commission Order Nos. PSC-02-0413-FOF-TP and PSC-02-0878-FOF-TP along with a Notice of Intent to Request Specified Confidential Classification. Portions of BellSouth's Motion contained information that may be considered confidential and proprietary to Supra.
3. The subject information references Supra's account records, which may be prohibited from being disclosed under Section 364.24, Florida Statutes. Accordingly, the subject information may be entitled to confidential classification, pursuant to Section 364.183(3), Florida Statutes.

4. A more specific description of this information is contained in Attachment A. This information may be valuable to Supra and BellSouth has not disclosed it. Therefore, such information should be classified as proprietary, confidential business information pursuant to §§ 364.183(3)(e), Florida Statutes. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

5. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.

6. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.

7. Appended hereto as Attachment C is a sealed envelope containing one copy of the documents including the material, which is confidential and proprietary.

WHEREFORE, based on the foregoing, BellSouth requests that the Commission enter an order declaring the information described above to be confidential, proprietary business information that is not subject to public disclosure.
