BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated June 19, 2002, New Century Telecom, Inc. (New Century Telecom) and Karyn Bartell filed with this Commission an application for approval of Transfer of Ownership from New Century Telecom to Karyn Bartell. New Century Telecom is the holder of IXC

Certificate No. 4378. New Century Telecom has stated that the transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided. New Century Telecom has stated that it will continue to operate under its existing certificated name and tariff on file with this Commission.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of New Century Telecom and Karyn Bartell, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that New Century Telecom, Inc. and Karyn Bartell's request for approval of Transfer of Ownership from New Century Telecom, Inc. to Karyn Bartell is hereby approved. It is further
