ORDER GRANTING IN PART AND DENYING IN PART FLORIDA POWER & LIGHT COMPANY'S REQUEST FOR CONFIDENTIAL CLASSIFICATION FOR CERTAIN DOCUMENTS PROVIDED AS RESPONSES TO STAFF'S REQUEST FOR PRODUCTION OF DOCUMENTS NOS. 18 AND 19

On September 6, 2002, Florida Power & Light Company (FPL), pursuant to Section 366.093, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, filed a Request for Confidential Classification for certain documents provided in response to Staff's Request for Production of Documents (PODs) Nos. 18 and 19. The information was filed with the Commission as Document No. 09503-02.

In support of its request for confidential classification of the POD Responses, FPL asserts that the information contained therein is entitled to confidential classification pursuant to Section 366.093(3)(e), Florida Statutes. FPL states that this information consists of rating agency presentations made by FPL to Standard & Poors and Moody's Investment Services. FPL asserts that the public disclosure of this information would cause irreparable harm to the competitive interests of FPL, as the revelation of detailed financial forecasts would impair FPL's competitive business interests by revealing competitive financial and generation strategies. FPL asserts that this information is intended to be, and has been treated by FPL as private and confidential, and has not been publicly disclosed.

FPL has supplied a page by page and line by line listing of the specific information which it asserts is confidential, which is attached hereto as Exhibit A. I have reviewed the listing supplied

by FPL, and have determined that it adequately and sufficiently identifies the specific information for which FPL requests confidentiality, in compliance with Rule 25-22.006, Florida Administrative Code.

Upon review, it appears that the majority of the information for which confidential classification is sought contains proprietary, confidential information which, if disclosed, would impair the competitive business of FPL. The specific information granted confidential classification is listed below:

Accordingly, I hereby grant FPL's request for confidential classification for the information identified in the table above, and contained in Document No. 09503-02.

Pages 00115938ND and 00115922ND also contain data entitled "2001 Actual". This information is not based upon forecasted or projected amounts; nor does it appear to relate to competitive financial strategies and interests, the disclosure of which would impair the competitive business of FPL. Accordingly, I hereby deny the request for confidential classification for the data listed in the 2001 Actual columns on pages 00115938ND and 00115922ND.

Section 366.093(4), Florida Statutes, provides that any finding by the Commission that records contain proprietary

confidential business information shall be effective for a period not to exceed 18 months, unless the Commission finds good cause to specify a longer period. FPL has requested protection for a period of 36 months, alleging that much of the information contains forecasts through the year 2005. As such, I find it is appropriate that the information in Document No. 09503-02, granted confidentiality above, shall remain confidential for a period of 36 months from the date of issuance of this Order.

Based on the foregoing, it is

ORDERED by Commissioner J. Terry Deason, as Prehearing Officer, that Florida Power & Light Company's Request for Confidential Classification is granted in part and denied in part as set forth in the body of this Order. It is further

ORDERED that the information described within the body of this Order and contained in Document No. 09503-02 is granted confidential classification for a period of thirty-six (36) months from the date of this Order, in the absence of a renewed request for confidentiality pursuant to Section 366.093(4), Florida Statutes. It is further

ORDERED that this Order shall be the only notification by the Commission to the parties of the declassification date of this information.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
