

On December 20, 2002, I submitted to the Public Service Commission the application of Farmton Water Resources, LLC to operate a water utility in Volusia and Brevard Counties. As part of that application, two copies of Exhibit G were submitted as a depiction of the service territory of the utility showing township, section and range references. A small portion of that territory is within what is known as the Bernardo Sequi Grant in Brevard County. The maps, as originally submitted, did not show the township, section and range references for that portion of the territory.

I am sending two copies of a revised Exhibit G to include township, section and range references to the Bernardo Sequi Grant area in the southern part of the proposed territory. These two maps are being sent directly to Richard Redemann in the Commission's Economic Regulation Division. These maps should replace those submitted on December 20 as Exhibit G.
