Wayne, as I understand it, you're wanting to reissue a PAA order as an order approving settlement (I know this is one of those I sent you an e-mail on earlier). No. 1, we can't do that because we use "PAA" as the order designator for PAAs and "AS" for orders approving settlement--thus we couldn't reissue a PAA as an AS. No. 2, I believe what you actually need to do is (a) issue an order vacating the PAA order and then (b) issue the order approving settlement.

Can you check on this and advise? We of course won't issue the reissued order till we hear from you--but we'll have a problem with the order designator if you want to go forward with reissuing.
