Thank you for your letter dated July 25, 2002, which we received via e-mail to Ralph Jaeger of the Commission's legal staff, regarding the service availability charges for Aloha Utilities, Inc.'s (Aloha) Seven Springs wastewater system.

As you requested, we are happy to provide you with a summary of the facts of this matter. By Order No. PSC-01-0326-FOF-SU, issued February 6, 2001, the Commission approved an increase in rates for Aloha's Seven Springs wastewater system. The Commission also directed Aloha to increase its wastewater service availability charges for this system from \$206.75 per equivalent residential connection (ERC) to \$1,650 per residential ERC and \$12.79 per gallon for all other connections.

Aloha noticed customers of the rate increase and submitted to the Commission staff the revised tariff sheets for the increased rates. As a result, the effective date of these tariff sheets for the increased rates was May 23, 2001. The above order also required Aloha to notice the increased service availability charges and submit revised tariff sheets for the increased charges. However, in late February or early March, 2002, the Commission staff discovered that Aloha had not submitted its revised tariff sheets. On March 11, 2002, Aloha submitted the revised tariff sheets for the increased charges, but did not begin noticing developers or builders of the increased service availability charges until April 16, 2002. As such, the Commission initiated Docket No. 020413-SU to address Aloha's apparent violation of Order No. PSC-01-0326-FOF-SU.

Staff is scheduled to file its recommendation regarding this matter on August 8, 2002, for the Commission's consideration at its August 20, 2002 Agenda Conference. This recommendation will address: 1) Aloha's proposed settlement agreement; 2) Aloha's apparent violation of a Commission

Subject: Aloha Utilities - Docket# 020413-SU To Whom It May Concern,

I am a little bit surprised that this issue has gotten this far which is why it has taken so long to respond. A building was built with a purchase price based on the cost associated (Including water and sewer impact fees) to build and a profit. This building was sold approximately June of 2002 and these back billed impact fees were not included in the sale price. A product price is arrived at by the cost to produce and a profit margin. You cannot go back to the purchaser of a product and tell them that a mistake was made and you owe an additional amount of money. That is not the way a business is run.

Additionally, when I started another project in the same industrial park, Aloha Utilities refused to inspect the water and sewer for this project until these back billed fees had been paid.

One more area of concern is the amount of the increase that was approved for water and sewer impact fees. The impact fees for first project was completed approximately April 2002 was almost \$1,000.00 and the impact fees for the current project started approximately September of 2002 was almost \$14,000.00. That is an increase of almost 1400 percent. The two buildings are almost identical at 7800SF. The new project had a couple hundred more SF of office, but had one less bathroom. How can an increase of 1400 percent be expected or justified in such a short period of time. With the buildings being almost identical and construction so close together, the impact fees originally used in the price being quoted to potential customers was only about \$2,000.00 which is double what was used just 6 months earlier.

The above issues do not appear to be realistic and how the process should be approached. I hope these issues can be resolved.
