This letter is to verbalize my feelings regarding the poor water quality and poor service provided by Sunshine Utilities, Inc. of Central Florida.

I have owned my home at 2697 NE 60th Lane, Eleven Oaks Subdivision, Phase One, Ocala, Florida since March 15, 1997.

During the first few months of owning my home, I notice a strong smell of chlorine in the water, and my skin was becoming very dry, as well as my hair Bleaching out dramatically.

I contacted Culligan Water of Florida and had them do a test on my water. I was told that the chlorine level in the water was stronger than that of swimming pool water.

I have to pay Culligan water the following to bring the chlorine level to one that is safe for water consumption: \$80.00 a quarter for a new chlorine tank and \$10 as a monthly fee, which comes to a total of \$360.00 per year.

I am paying Sunshine Utilities on the average of \$30.00 a month for what should be "safe and usable water" and this is not the case.

I am very unhappy about the quality of the water and ask that the commission look into this situation.

Dear Sir or Ma'am:

We have lived in Eleven Oaks Subdivision for in excess of ten years and have had Sunshine Utilities as our water service. During that time, we have had numerous problems which have been brought to the attention of Sunshine Utilities and, usually, the problems would be resolved for a short period of time, and would then resume in the same or worse condition as they originally existed.

The specific problems which we have experienced are excessive amounts of chlorine, rust in our water and sporadic water pressure.

Approximately two weeks ago, we received an extreme amount of rust in our cold water, such that a large quantity of our laundry was ruined, including towels and clothing. Once this rust is in towels and clothing it CANNOT be removed. If an item is one that can be bleached, even bleach will not remove it. In a discussion with a Sunshine Utilities employee, we was advised that when the water pressure fluctuates, it forces the rust from their pipes into our home. If this is so, why have the pipes not been flushed or cleaned such that the rust is removed from the pipes?

Our toilets regularly have rust stains in them, which will appear within a few hours after they have been cleaned.

On numerous occasions, we have bathed our two-year old son and been able to smell chlorine on his skin from the water. This cannot be healthy!

Probably 80% to 90% of the time, we are unable to use the ice from our ice maker because of the high chlorine content and we are required to purchase bottled water on a regular basis because our water tastes and smells awful and, again, it cannot be healthy to drink with such high chlorine content.

We have now received a notice wherein Sunshine Utilities is requesting a rate increase to "recover costs of water system improvements in Marion County". If, in fact, there have been any improvements, we are not aware of them and the quality of water has certainly not improved and, in fact, has been worse in the last two to three weeks.

We would respectfully request that you <u>deny</u> any rate increase to Sunshine Utilities and would further request that they be <u>required to resolve the existing water problems</u> in our subdivision.

My name is Lil Weiss and I own a home in the Davis Landfill area. I am here tonight to express my opinion about the proposed application of the rate increase that Sunshine Utilities has requested. I personally opposed the rate increase of 15.33% and I was told today that they are actually looking for a 17% rate increase. Why such a huge rate increase. Especially at this time when the economy is, does it seem fair to get a 17% rate increase? When the average customer is struggling to make ends meet, losing their jobs when companies are down sizing to stay in busniess, or even taking pay cuts to have a job to survive. How do we know as customers that Sunshine Utilities are actually putting this rate increase to the new systems and not lining their pockets with the revenues from the increase? How do we know the water quality will be better? How do we know that Sunshine Utilities are actually testing these systems like they say? Anyone can do reports and send out, do we know for sure these test or reports are correct? And if and when they put these systems in, what about the water sitting still stored in a tank, doesn't that cause any kind of bateria just sitting there? I don't feel Sunshine Utilities provides good customer service relationship to their customers or systems. I find Sunshine Utilities can't provide the answers to the questions when you asked them. It is right to ask all the 21 separate water systems Sunshine Utilities customers to want this rate increase just for the 5 systems that are in trouble with contamination. Do you really think they want to pay for that? I know I wouldn't.

I wouldn't have this system at all if Marion county Davis landfill didn't contaminated our private well. As you see I don't only have issues with Sunshine Utilities but with Marion county which makes this whole situation difficult. I don't agree with Sunshine Utilities because of all the problems I have with them at this time. They don't really stand behind their service or this systems installed. Thank you for your time and hearing out my opinion.
