

EXECUTIVE SUMMARY

Introduction

This filing provides for the expansion of flat rated expanded local exchange service in various areas of BellSouth's service area in Florida. This requires the elimination of Local Calling Plus (LCP), Extended Calling Service (ECS) and some toll on the routes involved, and also increases basic rates in accordance with the statute parameters.

Tariff Changes

This filing will change specific Local Calling Plan (LCP), Extended Calling Service (ECS) and toll routes to Extended Area Service. In addition, BellSouth is eliminating the X1, X2, X3 and X4 exception codes and moving these customers to the appropriate rate group based on the number of lines a customer can call. Further, BellSouth will increase rates across the state to reflect the allowable level for the basic basket.

Revenue Impact

The rate changes impact the Basic and Non-Basic Services baskets by the percentages listed below. These increases are within the limits allowed by statute.

1. Basic Services will increase by .53%
2. Non-Basic Service – Business Exchange will increase by .56%
3. Non-Basic Service – Residential Optional will decrease by .05%
4. Non-Basic Service – Business Optional will decrease by .05%
5. Non-Basic Service – Toll will decrease by .02%

For the services specified in A3.4.4, the local calling area of the exchange in the left hand column includes the additional exchanges listed in the EAS and ECS categories and all other exchanges in the subscriber's LATA.
