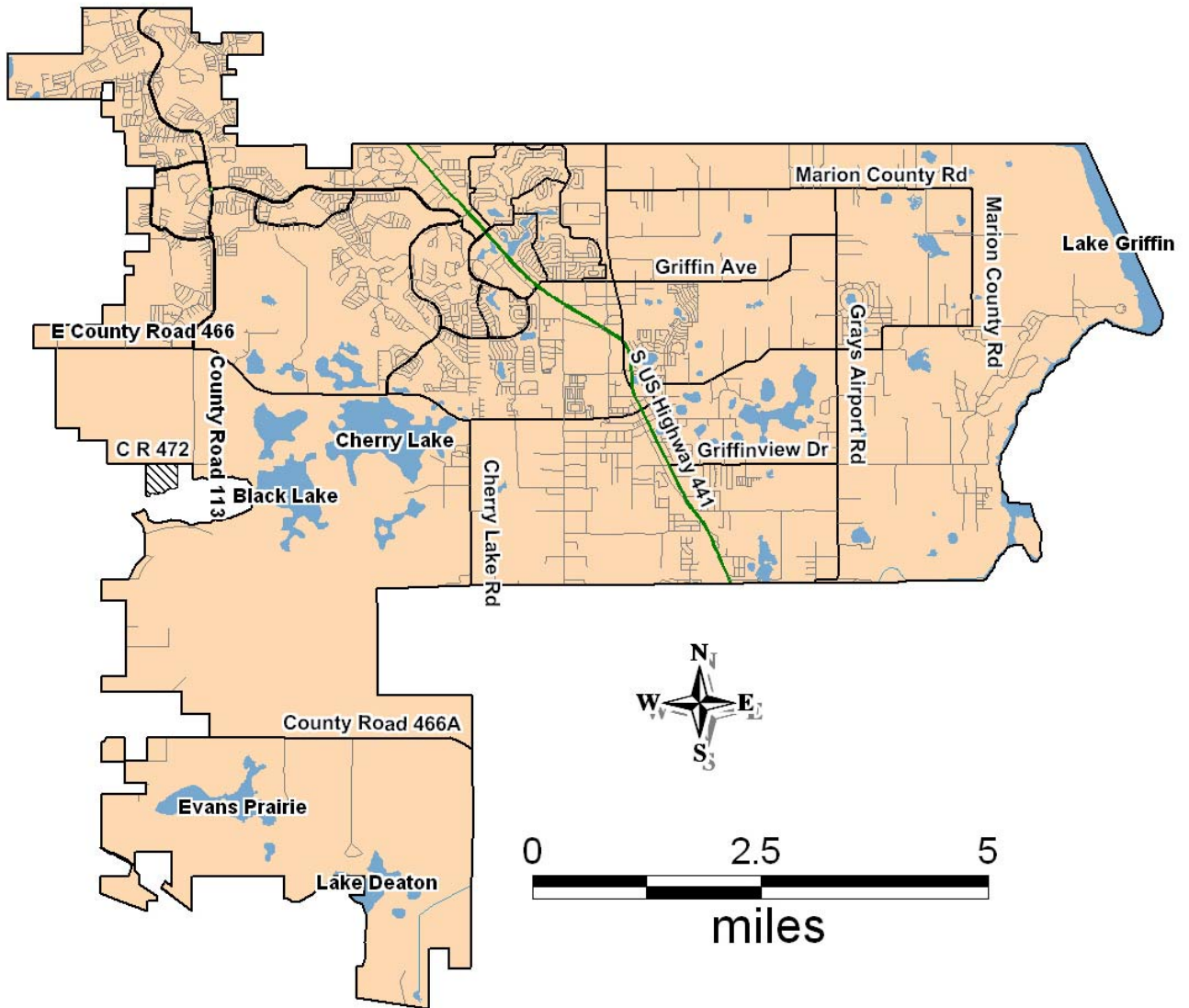

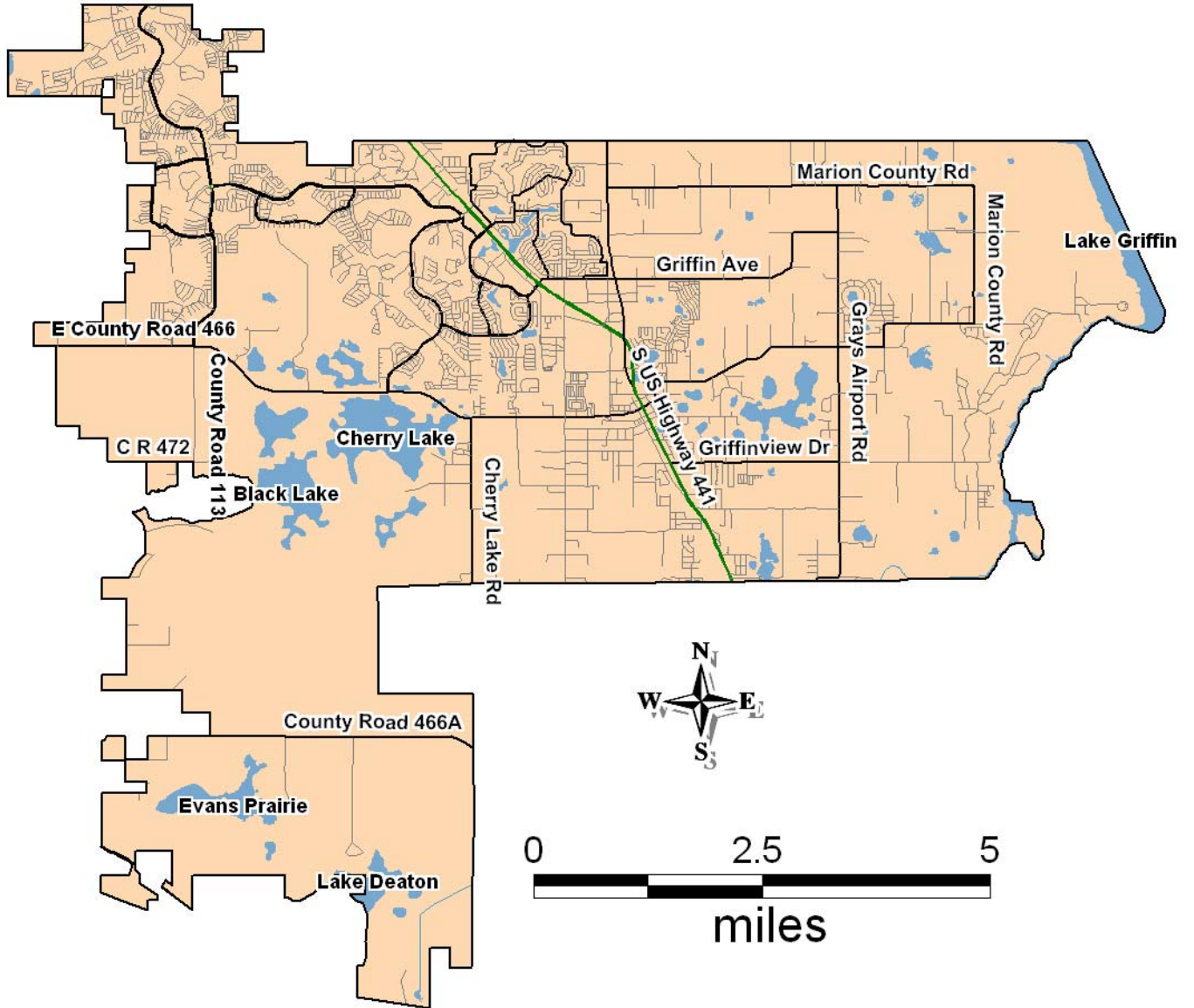

LADY LAKE



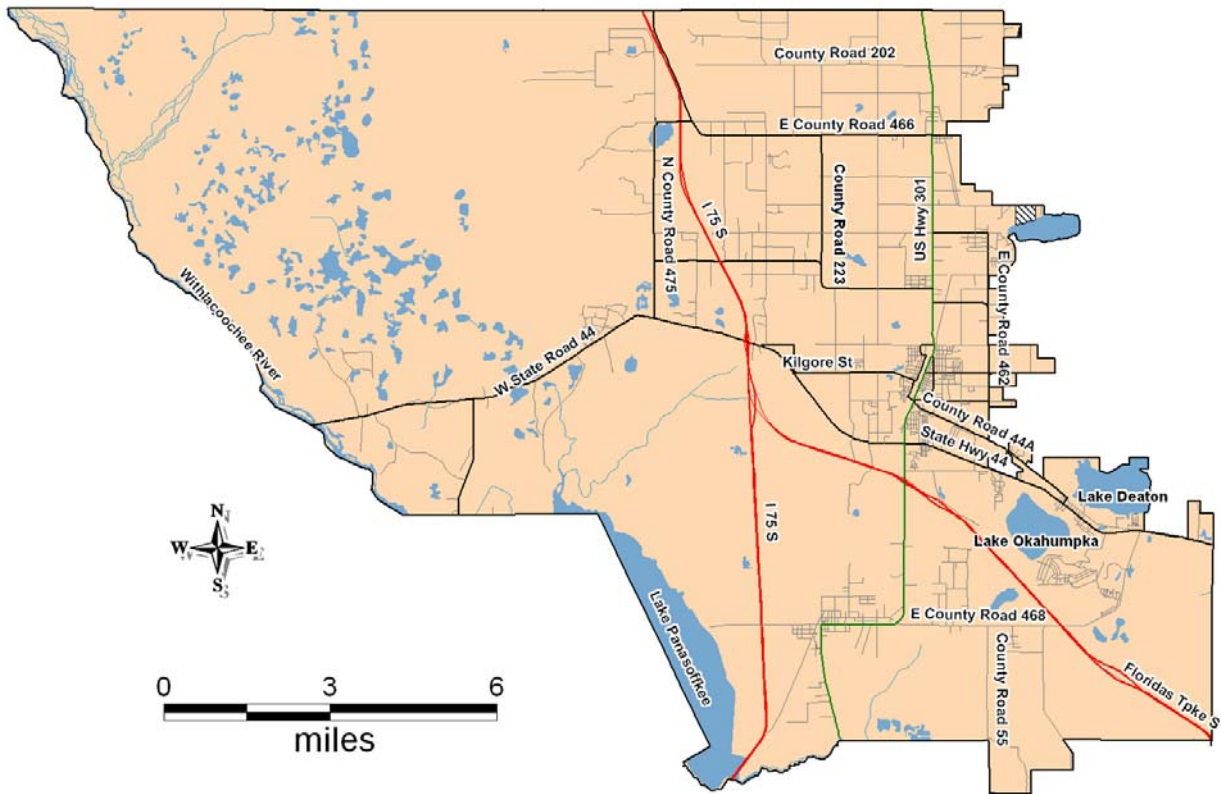
