ORDER AMENDING CERTIFICATE

BY THE COMMISSION:

On September 13, 1988, Spring Hill Utilities, a division of Deltona Utilities, Inc., ("Spring Hill"), applied for an amendment to Water Certificate No. 46-W, and Sewer Certificate No. 47-S to include and to delete territory, in Hernando County, Florida, pursuant to the provisions of Section 367.061, Florida Statutes.

In July, 1988, Spring Hill notified certificated utilities and appropriate governmental agencies in Hernando County of its intention to amend its Certificates to include the territory described in Appendix A, attached to this Order. Proof of notification has been provided by Spring Hill as prescribed by Rule 25-30.030, Florida Administrative Code.

Notice of Spring Hill's intent to expand and to delete its service area was published in the Sun Journal, a newspaper of general circulation in Hernando County, Florida, on July 19 and 26, and August 2, 1988, in accordance with Rule 25-30.030, Florida Administrative Code. No protests were received within the prescribed time period.

The appropriate filing fee has been paid. Adequate territorial and system maps, and a legal description have been provided in accordance with Rule 25-30.035, Florida Administrative Code. The utility is ready, willing, and able to provide service in the territory for which it has applied. The application has been reviewed and found to be in conformance with the statutory requirements. Accordingly, we find it is in the public interest to amend Certificates Nos. 46-W and 47-S to include the territory described for inclusion, and to delete the territory described for deletion, in Appendix A to this Order which by reference is incorporated herein.

It is therefore,

ORDERED by the Florida Public Service Commission that Certificates Nos. 46-W and 47-S, held by Spring Hill Utilities, a division of Deltona Utilities, Inc., 3250 South West Third Avenue, Miami, Florida 33129, are hereby amended to include the territory described for inclusion, and to delete the territory described for deletion in Appendix A of this Order. NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
