PURPOSE AND EFFECT: The intent of this new rule is to have a uniform size of paper used by and filed with the Commission.

SUMMARY: The rule will require all petitions, pleadings, and motions filed with the Commission to be on paper measuring 8 1/2 by 11 inches in size (i.e., letter-size). Likewise, Commission orders, opinions, and other official documents will be on letter-size paper. The rule provides exceptions for maps, spreadsheets, and filings with other agencies requiring legal-size paper.

RULEMAKING AUTHORITY: 120.53, F.S.

LAW IMPLEMENTED: 120.53, F.S.

SUMMARY OF THE ESTIMATE OF ECONOMIC IMPACT OF THESE RULES: The net effects of the proposed rule are difficult to assess due to the unquantifiable nature of the benefits involved. The magnitude of either net costs or net benefits is likely to be too small for the proposed changes to affect the present level of business expenses incurred by filing parties.

Rule 25-22.009 Size of Paper Filed With Commission.

- (1) Beginning on January 1, 1990, all petitions, pleadings, and motions filed with the Commission and all orders, opinions, and other official documents issued by the Commission shall be on paper measuring 8 1/2 by 11 inches in size. However, the Commission shall use legal-size paper when necessary to comply with the filing requirements of any court or other administrative body.
- (2) Correspondence and other documents filed with or issued by the Commission should also be on 8 1/2 by 11-inch paper where possible. Maps, data spreadsheets, and similar documents may be on larger paper.

STATEMENT OF FACTS AND CIRCUMSTANCES JUSTIFYING RULE

The Commission believes that requiring a uniform size of paper will promote efficiency, convenience, and economy in the exercise of its administrative duties.

STATEMENT ON FEDERAL STANDARDS

Although some federal agencies still use both letter- and legal-size paper, all federal courts now require the use of letter-size paper.

STATEMENT OF IMPACT ON SMALL BUSINESS

The proposed rule is not expected to have any impact on the approximately 380 small businesses which file with the FPSC every year. Based on the current number of filings annually, the additional costs, when considered for all filing parties, are small; and when attributed to each party, they are likely to be too insignificant to affect business expenses noticeably.
