ORDER AMENDING CERTIFICATES TO INCLUDE
ADDITIONAL TERRITORY

BY THE COMMISSION:

On October 27, 1989, Hydratech Utilities, Inc. (Hydratech or Utility) filed an application with the Commission to amend its Certificates Nos. 337-W and 292-S to include additional territory in Martin County, Florida, pursuant to the provisions of Section 367.061, Florida Statutes.

On September 21, 1989, Hydratech notified certificated utilities and appropriate governmental agencies in Martin County of its intention to amend its Certificates to include the territory described in Appendix A, attached to this Order. Proof of Notification has been furnished by the Utility.

Notice of the Utility's intent to extend its service area was published in The Stuart News, a newspaper of general circulation, published in Martin County, Florida, on October 13, 20, and 27, 1989. No protests to this application were received within the prescribed time period.

The appropriate filing fee has been paid, and the Utility is ready, willing and able to provide service in the territory for which it has applied. The application has been reviewed and found to be in compliance with the statutory requirements. Accordingly, we find it is in the public interest to amend Certificates Nos. 337-W and 292-S to include the territory described in Appendix A to this Order, which by reference is incorporated herein.

It is, therefore,

ORDERED by the Florida Public Service Commission that Certificates Nos. 337-W and 292-S, held by Hydratech Utilities, Inc., 6570 S.E. Federal Highway, Stuart, Florida 34997, are hereby amended to include the territory described in Appendix A of this Order. The Utility is directed to return Certificates Nos. 337-W and 292-S to this Commission within 20 days of the date of this Order for appropriate entry. It is further

THAT PORTION OF THE GOMEZ GRANT LYING NORTH OF S.E. BRIDGE ROAD AND LYING WEST OF A CURVILINEAR LINE THAT IS 5300 FEET WEST OF AND PARALLEL TO U.S. HIGHWAY NO. 1 (STATE ROAD NO. 5);

THAT PORTION OF THE GOMEZ GRANT LYING SOUTH OF S.E. BRIDGE ROAD AND WEST OF S.E. FLORA AVENUE;

THAT PORTION OF SECTION 28, TOWNSHIP 39 SOUTH, RANGE 42 EAST LYING WEST OF S.E. FLORA AVENUE;

THAT PORTION OF SECTION 33, TOWNSHIP 39 SOUTH, RANGE 42 EAST LYING OUTSIDE THE BOUNDARY OF JONATHAN DICKINSON STATE PARK;

THAT PORTION OF THE NORTHEAST ONE-QUARTER OF SECTION 32, TOWNSHIP 39 SOUTH, RANGE 42 EAST LYING EAST OF S.E. POWERLINE ROAD.

THAT PORTION OF THE GOMEZ GRANT LYING SOUTH OF S.E. BRIDGE ROAD AND WEST OF S.E. FLORA AVENUE;

THAT PORTION OF SECTION 28, TOWNSHIP 39 SOUTH, RANGE 42 EAST LYING WEST OF S.E. FLORA AVENUE;

THAT PORTION OF SECTION 33, TOWNSHIP 39 SOUTH, RANGE 42 EAST LYING OUTSIDE THE BOUNDARY OF JONATHAN DICKINSON STATE PARK;
