ORDER REQUIRING FILING OF MODIFIED  
MINIMUM FILING REQUIREMENTS

BY THE COMMISSION:

Section 364.035(3), Florida Statutes (1990), now requires that each local exchange company (LEC) file modified minimum filing requirements (MMFRs) within eighteen (18) months after October 1, 1990. By Order No. 23452, as amended, in Docket No. 900655-TL, we established our projected MMFR filing date schedule for all LECs in Florida. Pursuant to the directive contained in that Order, this docket has been initiated to determine specific MMFR issues for Vista-United Telecommunications (Vista-United or the Company).

Upon consideration of the factors specified in Section 364.035(3), we find it appropriate to require Vista-United to file MMFRs as shown in Attachment I to this Order. This filing shall be completed by March 31, 1991. The filing shall be based on the calendar year 1990, which will be the most current historical period available at that time. The schedules delineated in Attachment I represent reduced filing requirements deemed appropriate due to the relatively small size of the Company. We note that circumstances may warrant further modification of the requirements set forth herein, given an appropriate showing by the Company.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Vista-United Telecommunications shall file its modified minimum filing requirements in accordance with the terms set forth herein. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and

the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure.
