ORDER CLOSING DOCKET

BY THE COMMISSION:

Florida Power Corporation (FPC) has submitted a bid to purchase the distribution and administrative facilities of Sebring Utilities Commission (SUC). The terms of FPC's bid included approval by this Commission of a surcharge on the customers residing in the territory currently served by Sebring Utilities to offset the purchase price of the system in excess of book value.

On July 1, 1991 FPC filed a petition requesting the "initiation of a proceeding to consider a petition for approval of a transition rate applicable to electric customers in the area currently served by the SUC, such petition to be filed immediately upon SUC's acceptance of the Company's proposal to purchase the electric distribution system of SUC." There was some urgency at that time to have a tariff approved and in place by October 1, 1991. On August 5, 1991, FPC filed a letter stating that the accelerated timetable was no longer applicable and asking that this proceeding be held in abeyance pending further action by the SUC (ie., the award of a bid to purchase the system).

Based on the foregoing it is

ORDERED by the Florida Public Service Commission that this docket shall be CLOSED.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
