ORDER ACKNOWLEDGING WITHDRAWAL OF PROTEST

BY THE COMMISSION:

On August 24, 1992, the Foxridge Subdivision Homeowners Association (Homeowners Association) filed a Petition requesting that the Tampa-North exchange be extended to include the Country Crossing subdivision, which is located in the Zephyrhills exchange. On June 9, 1993, we issued Order No. PSC-93-0868-FOF-TL, Notice of Proposed Agency Action Order Denying Petition. The Homeowners Association and Mr. Patrick Bellaire, separately, filed timely protests to the Order. The matter was set for hearing for October 12, 1994.

The Homeowners Association withdrew its protest before a hearing was scheduled. On July 15, 1994, the Commission received a letter from Mr. Bellaire withdrawing his protest.

Based on the foregoing, we hereby acknowledge the withdrawal of Mr. Patrick Bellaire's protest and declare Order No. PSC-93-0868-FOF-TL final.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water or sewer utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Civil Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
