ORDER GRANTING MOTION FOR CONTINUANCE

This matter was scheduled for a formal hearing on February 8-9, 1995, in Lake County, Florida, to address the provision of service provided by JJ's Mobile Homes, Inc. (JJ's). On February 2, 1995, the Office of Public Counsel (OPC) filed a Motion for Continuance. In its Motion, OPC alleges that the hearing location of Leesburg is not convenient to the utility's service territory, that the parties' positions have changed since the original prehearing order was issued, and that several discovery matters, including a petition filed in Circuit Court, are pending. OPC requested that the hearing be continued for a period of at least 90 days. The utility objected to the continuance.

On February 3, 1995, an emergency telephonic motion hearing was conducted in order to address the Motion to Continue. After consideration of the parties' positions, it is appropriate to cancel the hearing set for February 8-9, 1995. The scheduling of key dates in this docket, including discovery and testimony, will be addressed in a separate order.

Based upon the foregoing, it is

ORDERED by Commissioner Julia L. Johnson, as Prehearing Officer, that the hearing in this matter scheduled for February 8-9, 1995, is hereby cancelled.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by this Order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.038(2), Florida Administrative Code, if issued by a Prehearing Officer; (2) reconsideration within 15 days pursuant to Rule 25-22.060, Florida Administrative Code, if issued by the Commission; or (3) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of Records and Reporting, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
