NOTICE OF PROPOSED AGENCY ACTION
ORDER IMPOSING FINE OR CANCELLING CERTIFICATE

BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Mail sent to RD&J Communications, Inc. (RD&J) was returned to our Division of Records and Reporting by the United States Postal Service. Our staff attempted to contact RD&J by telephone at the number listed in our records. Our staff also attempted to find a new telephone number for both the company and the company's Commission liaison but neither the company nor its liaison had a listing in directory assistance.

Rules 25-24.480(3)(a) and (b), Florida Administrative Code, require an interexchange carrier to inform this Commission within 10 days if there is a change in the company name, its address, its telephone number, or its Commission contact person. By failing to inform this Commission of changes in address and telephone number, RD&J is in apparent violation of Rules 25-24.480(3)(a) and (b),

Florida Administrative Code. Pursuant to Chapter 364, Florida Statutes, and Rule 25-24.474, Florida Administrative Code, we may impose a fine or cancel a certificate for violation of our Rules or orders.

Accordingly, we order RD&J to pay a \$250 fine and provide the Commission with the information required by Rules 25-24.480(3)(a) and (b), Florida Administrative Code, within 30 days of the date this Order becomes final. If RD&J complies, this docket will be closed. If RD&J fails to comply with this Order, Certificate No. 3503 will be cancelled and this docket will be closed.

It is, therefore

ORDERED by the Florida Public Service Commission that RD&J Communications, Inc. pay a \$250 fine and provide the Commission with the information required by Rules 25-24.480(3)(a) and (b), Florida Administrative Code, within 30 days of the date this Order becomes final. It is further

ORDERED that if RD&J Communications, Inc. complies with this Order, this docket will be closed. It is further

ORDERED that if RD&J Communications, Inc. does not comply with this Order, Certificate No. 3503 will be cancelled and this docket will be closed.

ORDERED that, unless a person whose substantial interests are affected by the action proposed herein files a petition in the form and by the date specified in the Notice of Further Proceedings or Judicial Review, below, this Order shall become final.
