ORDER ACKNOWLEDGING NAME CHANGE

By letters dated May 28, 1996, and June 14, 1996, Time Warner AXS of Florida, L.P., holder of Alternative Access Vendor Certificate of Public Convenience and Necessity Number 3167, requested that Certificate Number 3167 be amended to reflect the fictitious name "Time Warner AXS of Florida, L.P., d/b/a Time Warner Communications." Upon review of the Department of State, Division of Corporations' records, it appears that Time Warner AXS of Florida, L.P. has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate Number 3167 to reflect the new operating name.

This Order will serve as Time Warner AXS of Florida, L.P., d/b/a Time Warner Communications' amended Alternative Access Vendor Certificate of Public Convenience and Necessity Number 3167. Time Warner AXS of Florida, L.P., d/b/a Time Warner Communications should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Time Warner AXS of Florida, L.P. to change the name on Certificate Number 3167 from Time Warner AXS of Florida, L.P. to Time Warner AXS of Florida, L.P., d/b/a Time Warner Communications is approved. It is further

ORDERED that this change will be effective ten (10) days from the issuance of this Order. It is further

ORDERED that this docket is hereby closed.



NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.59(4), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
