BEFORE THE FLORIDA PUBLIC SERVICE COMMISSION

AMENDATORY ORDER

On December 2, 1996, Order No. PSC-96-1457-FOF-EI, <u>Final Order Granting Florida Power & Light Company Authority to Issue and Sell Securities</u> was issued. After issuance several scrivener's errors were noted in the Order. To correct these errors, the text of Order No. PSC-96-1457-FOF-EI is amended as follows:

On Page 1, the second paragraph, line 3, the word "convertibles" is corrected to "convertible."

On Page 3, the first sentence of the first paragraph is replaced with the following sentence: "FPL further states the exchange of its securities may be by way of an exchange of a security of FPL for another security or securities of FPL or of one of its subsidiaries or affiliates or the exchange of a security of FPL or of one of its subsidiaries or affiliates for the security or securities of another entity."

On Page 3, the second paragraph, strike the words "not to exceed 25% of the company's gross annual revenues."

On Page 3, last paragraph, line 12, insert the word "debt" after the word "long-term."

On Page 4, second paragraph, line 4, substitute the word "in" for the word "between." In the same paragraph, line 6 add the word "First" between "FPL" and "Mortgage Bonds."

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Order No. PSC-96-1457-FOF-EI is amended as discussed in the body of this Order. It is further

ORDERED that Order No. PSC-96-1457-FOF-EI is affirmed in every other respect.
