ORDER AMENDING CERTIFICATE TO INCLUDE
ADDITIONAL TERRITORY AND CLOSING DOCKET
BY THE COMMISSION:

## Background

Florida Water Services Corporation (formerly Southern States Utilities, Inc., and hereinafter Florida Water or utility) is a Class A utility which provides water and wastewater service to approximately 83,286 water customers and 43,527 wastewater customers in 28 counties in Florida. The utility's 1995 annual report shows an annual operating revenue of $\$ 52,077,478$ and a net operating income of $\$ 2,356,915$.

On September 30, 1996, Florida Water filed an application, pursuant to Section 367.045, Florida Statutes, and Rule 25-30.036, Florida Administrative Code, to amend its wastewater Certificate No. 322-S to include additional territory in Marion County. Rule 25-30.036, Florida Administrative Code, sets forth the criteria for an expedited proceeding that applies to any certificated water or wastewater utility that proposes to extend its service territory into an area in which there is no existing water or wastewater system, when there is no timely protest filed to the notice of application. The customer requesting service from Florida water stated that not only is its existing septic system over capacity, but also that new construction on the lot necessitates removal of the tank. Florida Water proposes to extend its wastewater lines to serve this customer.

## Application

Florida Water's application is in compliance with Section 367.045, Florida statutes, and other pertinent statutes and provisions of the Florida Administrative Code concerning an application for amendment of certificate. In particular, the application contains a filing fee in the amount of $\$ 100$, as prescribed by Rule $25-30.020$, Florida Administrative Code. In addition, Florida Water has provided evidence, in the form of a warranty lease, that it owns the land upon which its facilities are

located, as required by Rule 25-30.036, Florida Administrative Code.

Adequate service territory and system maps and a territory description have been provided, as prescribed by Rule 25-30.036, Florida Administrative Code. The additional territory which Florida Water is requesting to serve in Marion County is described in Attachment A of this Order. The new territory will be added to the utility's South Forty wastewater service area as described in Attachment B. The application contains proof of compliance with the noticing requirements of Rule $25-30.030$, Florida Administrative Code. No objections to the notice of application have been received and the time for filing such has expired.

Accordingly, we find that it is in the public interest to amend Certificate No. 322-S to include the territory described in Attachment $A$ of this Order, which by reference is incorporated herein.

## Rates and Charges

Florida Water's approved rates and charges were effective September 20, 1996, pursuant to Order No. PSC-96-1320-FOF-WS, issued October 30, 1996 in Docket No. 950495-WS. Florida Water has filed revised tariff sheets incorporating the additional territory into its tariff and returned its certificate for entry reflecting the additional territory. Florida Water shall charge the customers in the territory added herein the rates and charges contained in its tariff until authorized to change by this Commission in a subsequent proceeding. No further action is required; therefore, this docket shall be closed.

It is, therefore,
ORDERED by the Florida Public Service Commission that Certificate No. 322-S, held by Florida Water Services Corporation, 1000 Color Place, Apopka, Florida 32703, is hereby amended to include the territory described in Attachment A of this Order, which by reference is incorporated herein. It is further

ORDERED that Florida Water Services Corporation shall charge the customers in the territory added herein the rates and charges approved in its tariff until authorized to change by this Commission. It is further

## NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68 , Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of Records and Reporting, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of Records and Reporting and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110 , Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900 (a), Florida Rules of Appellate Procedure.
