ORDER ACKNOWLEDGING SALE, CANCELLING CERTIFICATES AND CLOSING DOCKET

BY THE COMMISSION:

On December 4, 1996, William C. Demetree and Jack C. Demetree d/b/a Demetree Enterprises (Demetree or Utility) filed an application with this Commission for acknowledgment of the transfer of its water and wastewater facilities to the City of Jacksonville, Department of Public Utilities (City of Jacksonville), in Duval County, Florida. The sale occurred on November 6, 1996.

The provisions of Section 367.071, Florida Statutes, require an application for approval of sale or transfer of water and/or wastewater utilities to governmental agencies. However, the sale or transfer of the facilities to a governmental authority is approved as a matter of right. Section 367.071(4)(a), Florida Statutes.

Rule 25-30.037(4)(g), Florida Administrative Code, requires a utility to submit a statement regarding disposition of customer deposits when a utility is transferred. There were no customer regulatory assessment fees have been met, and there are no dockets pending involving this system.

Pursuant to Rule 25-30.037(4)(e), Florida Administrative Code, Demetree provided a statement that the City of Jacksonville has obtained from the utility the most recent available income and expense statement, balance sheet, statement of rate base for regulatory purposes and contributions-in-aid-of-construction.

On the basis of the foregoing, we find it appropriate to acknowledge the transfer of Demetree to the City of Jacksonville and to cancel Certificates Nos. 547-W and 477-S. Demetree shall return the Certificates to this Commission within 20 days of the date of this Order for cancellation.
