GCEC further represents that granting this request for an extension of the time for filing post-hearing briefs in this docket will not adversely effect any party to these proceedings. Good cause having been shown, it is found that the requested relief should be granted.

In consideration of the foregoing, it is

ORDERED by Susan F. Clark, as Prehearing Officer, that Gulf Coast Electric Cooperative's request for an extension for the filing of post-hearing briefs in Docket No. 930885-EU from August 25, 1997 to September 12, 1997, is granted.
