BY THE COMMISSION:

On July 29, 1997, we issued Order No. PSC-97-0891-FOF-TP in the above mentioned Docket. The Order granted approval of transfer of controlling stock interest to the above listed entities. Due to a scrivener's error in the caption of the Order, however, the name of the transaction was incorrectly identified as "Joint petition for approval of transfer of controlling stock interest in Arrow Communications, Inc. (Holder of ALEC Certificate No. 4468; IXC Certificate No. 3498 (in the name Arrow Communications, Inc. d/b/a Indiantown Telephone Long Distance, Co.) from Arrow Communications, Inc. to Postco, Inc. and canceling PATS Certificate No. 4939 in the name Arrow Communications, Inc." The correct caption should read: "Joint petition for approval of transfer of controlling stock interest in Arrow Communications, Inc. (Holder of Alternative Local Exchange Certificate No. 4468 and Interexchange Telecommunications Certificate No. 3498, in the name of Arrow Communications, Inc. d/b/a Indiantown Telephone Long Distance, Co.) from Indiantown Company, Inc. to Postco, Inc. and canceling Pay Telephone Service Certificate No. 4939 in the name of Arrow Communications, Inc."

Further, due to scrivener's errors in the body of the Order, the name of Arrow Communications, Inc. was incorrectly stated as Arrow Communication, Inc., and Indiantown Telephone System, Inc. was incorrectly reflected as being the holder of Certificate Number
