NOTICE OF PROPOSED AGENCY ACTION  
ORDER CANCELLING ALTERNATIVE LOCAL EXCHANGE  
TELECOMMUNICATIONS CERTIFICATE

BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Alliance Tel-Com, Inc. (Alliance Tel-Com), holder of Alternative Local Exchange Telecommunications Certificate (ALEC) of Public Convenience and Necessity No. 7850, has requested the cancellation of ALEC Certificate No. 7850. Alliance Tel-Com has complied with the provision of Rule 25-24.820(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its ALEC certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2000. Accordingly, we find it appropriate to cancel ALEC Certificate No. 7850, effective December 6, 2001. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. A RAFs Return notice for the year 2001 has been mailed to Alliance Tel-Com for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive a RAFs Return notice for the year 2001 shall relieve Alliance Tel-Com from its obligation to pay RAFs for the year 2001.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Alliance Tel-Com, Inc.'s Certificate No. 7850 to provide Alternative Local Exchange Telecommunications services is hereby canceled, effective December 6, 2001. It is further


ORDERED that Alliance Tel-Com, Inc. shall remit Regulatory Assessment Fees for the year 2001. It is further

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

The action proposed herein is preliminary in nature. Any person whose substantial interests are affected by the action proposed by this order may file a petition for a formal proceeding, in the form provided by Rule 28-106.201, Florida Administrative Code. This petition must be received by the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, by the close of business on January 31, 2002.
