ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated February 19, 2002, KMC Telecom III, Inc., holder of Interexchange Telecommunications (IXC) Certificate of Public Convenience and Necessity No. 7092 and Alternative Local Exchange (ALEC) Certificate of Public Convenience and Necessity No. 7093, requested that IXC Certificate No. 7092 and ALEC Certificate No. 7093 be amended to reflect the new corporate name, KMC Telecom III LLC. Upon review of the Department of State, Division of Corporations' records, it appears that KMC Telecom III, Inc. has properly registered the new corporate name. Accordingly, we find it appropriate to amend IXC Certificate No. 7092 and ALEC Certificate No. 7093 to reflect the new corporate name.

This Order will serve as the amended IXC Certificate of Public Convenience and Necessity No. 7092 and as the amended ALEC Certificate of Public Convenience and Necessity No. 7093 for KMC Telecom III LLC. KMC Telecom III LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by KMC Telecom III, Inc. to change the name on Interexchange Telecommunications Certificate No. 7092 from KMC Telecom III, Inc. to KMC Telecom III LLC is hereby approved. It is further

ORDERED by the Florida Public Service Commission that the request by KMC Telecom III, Inc. to change the name on Alternative Local Exchange Telecommunications Certificate No. 7093 from KMC Telecom III, Inc. to KMC Telecom III LLC is hereby approved. It is further

Any party adversely affected by the Commission's final action in this matter may request: 1) reconsideration of the decision by filing a motion for reconsideration with the Director, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
