ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated November 4, 2002, Coral Telecom, Inc., holder of Alternative Local Exchange Company Certificate of Public Convenience and Necessity No. 7512, requested that Certificate No. 7512 be amended to reflect the inclusion of a fictitious name, Coral Telecom, Inc. d/b/a TruComm Southeast. Upon review of the Department of State, Division of Corporations' records, it appears that Coral Telecom, Inc. has properly registered the fictitious name. Accordingly, we find it appropriate to amend Certificate No. 7512 to reflect the new operating name.

This Order will serve as Coral Telecom, Inc. d/b/a TruComm Southeast's amended Alternative Local Exchange Company Certificate of Public Convenience and Necessity No. 7512. Coral Telecom, Inc. d/b/a TruComm Southeast should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Coral Telecom, Inc. to change the name on Certificate No. 7512 from Coral Telecom, Inc. to Coral Telecom, Inc. d/b/a TruComm Southeast is hereby acknowledged. It is further

ORDERED that this Order will serve as Coral Telecom, Inc. d/b/a TruComm Southeast's amended certificate and that this Order should be retained as evidence of the name change. It is further

ORDERED that this change will be effective upon issuance of this Order. It is further



Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
