ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated November 13, 2002, Williams Local Network, LLC, holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7195, requested that Certificate No. 7195 be amended to reflect the new corporate name, WilTel Local Network, LLC. Upon review of the Department of State, Division of Corporations' records, it appears that Williams Local Network, LLC has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate No. 7195 to reflect the new corporate name.

This Order will serve as the amended Interexchange Telecommunications Certificate of Public Convenience and Necessity No. 7195 for WilTel Local Network, LLC. WilTel Local Network, LLC should retain this Order as evidence of the name change. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Williams Local Network, LLC to change the name on Certificate No. 7195 from Williams Local Network, LLC to WilTel Local Network, LLC is hereby approved. It is further

ORDERED that this Order will serve as WilTel Local Network, LLC's amended certificate and that this Order should be retained as evidence of the name change. It is further

Boulevard, Tallahassee, Florida 32399-0850, within fifteen (15) days of the issuance of this order in the form prescribed by Rule 25-22.060, Florida Administrative Code; or 2) judicial review by the Florida Supreme Court in the case of an electric, gas or telephone utility or the First District Court of Appeal in the case of a water and/or wastewater utility by filing a notice of appeal with the Director, Division of the Commission Clerk and Administrative Services and filing a copy of the notice of appeal and the filing fee with the appropriate court. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
