BY THE COMMISSION:

NOTICE is hereby given by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated January 14, 2003, RNK, Inc. d/b/a RNK Telecom, Inc. (RNK) filed with this Commission a request for approval of

change in corporate ownership whereby RNK will become a wholly owned subsidiary of RNK Holding Company. RNK is the holder of Interexchange Telecommunications Certificate No. 8265. RNK has stated that the reorganization will not affect RNK's business and operations, which will continue to be conducted through RNK. The transaction will be virtually transparent to its customers in Florida and it will not affect the services being provided.

In accordance with our authority under Section 364.33, Florida Statutes, to approve the acquisition or transfer of majority organizational control or controlling stock ownership of a telecommunications company providing service in Florida, we have reviewed the Petition of RNK, and find it appropriate to approve it. We have based our review and decision upon an analysis of the public's interest in efficient, reliable telecommunications service. We are vested with jurisdiction over this matter pursuant to Section 364.33, Florida Statutes.

Based on the foregoing, it is,

ORDERED by the Florida Public Service Commission that RNK, Inc. d/b/a RNK Telecom, Inc.'s request for approval of change in corporate ownership from RNK, Inc. d/b/a RNK Telecom, Inc. to RNK Holding Company is hereby approved. It is further
