BY THE COMMISSION:

Salvatore Belfiore d/b/a Sam's B Enterprises (Salvatore Belfiore), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 3440, has requested the cancellation of PATS Certificate No. 3440. Salvatore Belfiore has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its Regulatory Assessment Fees (RAFs) for the year 2002. Accordingly, we find it appropriate to cancel PATS Certificate No. 3440, effective February 10, 2003. We are vested with jurisdiction over this matter pursuant to Section 364.335, Florida Statutes.

In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calender year. A RAFs Return notice for the year 2003 will be mailed to Salvatore Belfiore for payment by January 30th. Neither the cancellation of its certificate nor the failure to receive RAFs Return notice for the year 2003 shall relieve Salvatore Belfiore from its obligation to pay RAFs for the year 2003.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Salvatore Belfiore d/b/a Sam's B Enterprises's Certificate No. 3440 to provide Pay Telephone services is hereby canceled, effective February 10, 2003. It is further

This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
