ORDER GRANTING BELLSOUTH'S REQUEST FOR DURATION OF ORDER NOS. PSC-01-2491-CFO-TP, PSC-01-2492-CFO-TP, PSC-01-2493-CFO-TP, PSC-01-2494-CFO-TP, AND PSC-01-2495-CFO-TP

24, 2003, BellSouth Telecommunications, On June Inc. (BellSouth) filed a Motion for Extension of Duration of Order Nos. PSC-01-2491-CFO-TP, PSC-01-2492-CFO-TP, PSC-01-2493-CFO-TP, PSC-01-2494-CFO-TP, and PSC-01-2495-CFO-TP, issued December 21, 2001, in Docket No. 990649-TP, which pre-dates the bifurcation of this Docket. Order No. PSC-01-2491-CFO-TP granted BellSouth's request for confidential classification of Document Nos. 09079-00 (x-ref 08201-00), 09050-00 (x-ref 08148-00), 08684-00 (x-ref 07823-00), Order No. PSC-01-2492-CFO-TP granted BellSouth's and 10477-00. request for confidential classification of Document Nos. 11631-00 (x-ref 11541-00), 11622-00 (x-ref 11436-00), 11619-00 (x-ref 11438-00), and 11628-00 (x-ref 11438-00). Order No. PSC-01-2493-CFO-TP granted BellSouth's request for confidential classification of Document No. 12002-00 (x-ref 10917-00). Order No. PSC-01-2494-CFO-TP granted BellSouth's request for confidential classification of Document Nos. 10943-00 (x-ref 09152-00 and 09153-00), 11042-00 (xref 09159-00 and 09163-00), 11048-00 (x-ref 09993-00 and 09994-00), and 11181-00 (x-ref 05385-00, 06296-00, and 10126-00). Order No. PSC-01-2495-CFO-TP granted BellSouth's request for confidential classification of Document Nos. 11249-00 (x-ref 10196-00 and 11246-00), 11536-00 (x-ref 10606-00), 12403-00 (x-ref 11179-00), and 12820-00 (x-ref 11634-00).

BellSouth contends that the reasons upon which BellSouth originally requested and was granted confidential treatment for these documents continue to apply. Furthermore, BellSouth still considers the information to be proprietary and treats it as such. Therefore, BellSouth asks that the confidentiality period for these documents be extended for a period of 18 months.

Florida law presumes that documents submitted to governmental agencies shall be public records. The only exceptions to this presumption are the specific statutory exemptions provided in the law and exemptions granted by governmental agencies pursuant to the DCCUMENT NUMBER-DATE

specific terms of a statutory provision. This presumption is based on the concept that government should operate in the "sunshine." Rule 25-22.006(4)(c), Florida Administrative Code, provides that it is the Company's burden to demonstrate that the documents fall into one of the statutory examples set out in Section 364.183, Florida Statutes, or to demonstrate that the information is proprietary confidential information, the disclosure of which will cause the Company or its ratepayers harm.

Upon consideration, I find that BellSouth's request complies with Rule 25-22.006(9), Florida Administrative Code. I note that our staff has retained the information at issue because this Docket, while bifurcated, remains open because it is on appeal. We have previously granted the information confidential treatment, and BellSouth asserts that it continues to treat the information as confidential. BellSouth further asserts that release of the information at this point in time would be detrimental to BellSouth. Therefore, BellSouth's request shall be granted. The confidentiality period shall be extended for a period of 18 months from the issuance of this Order.

Based on the foregoing, it is therefore

ORDERED by Chairman Lila A. Jaber, as Prehearing Officer, that BellSouth Telecommunications, Inc.'s Requests for Duration of Order Nos. PSC-01-2491-CFO-TP, PSC-01-2492-CFO-TP, PSC-01-2493-CFO-TP, PSC-01-2494-CFO-TP, and PSC-01-2495-CFO-TP regarding Document Nos. 09079-00 (x-ref 08201-00), 09050-00 (x-ref 08148-00), 08684-00 (xref 07823-00), 10477-00, 11631-00 (x-ref 11541-00), 11622-00 (xref 11436-00), 11619-00 (x-ref 11438-00), 11628-00 (x-ref 11438-00), 12002-00 (x-ref 10917-00), 10943-00 (x-ref 09152-00 and 09153-00), 11042-00 (x-ref 09159-00 and 09163-00), 11048-00 (x-ref 09993-00 and 09994-00), 11181-00 (x-ref 05385-00, 06296-00, and 10126-00), 11249-00 (x-ref 10196-00 and 11246-00), 11536-00 (x-ref 10606-00), 12403-00 (x-ref 11179-00), and 12820-00 (x-ref 11634-00) are hereby granted. ORDERED that pursuant to Section .364.183, Florida Statutes, and Rule 25-22.006, Florida Administrative Code, the confidentiality granted to the material identified herein shall expire eighteen (18) months from the date of the issuance of this Order, in the absence of a renewed request for confidentiality pursuant to Section 364.183, Florida Statutes. It is further

ORDERED that this Order will be the only notification by the Commission to the parties concerning the expiration of the confidentiality time period.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
