ORDER ON UNOPPOSED MOTION FOR EXTENSION  
OF TIME TO FILE PREHEARING STATEMENTS

On July 29, 2005, The Florida Retail Federation (FRF) filed its Unopposed Motion for Extension of Time to File Prehearing Statements (Motion). In support of its Motion, FRF states that pursuant to Order No. PSC-05-0487-PCO-EI, issued May 4, 2005, prehearing statements are currently scheduled to be filed on August 1, 2005. Due to pressing commitments on all parties to this case, the final list of issues, which is necessary for the parties to be able to prepare procedurally compatible prehearing statements, only became available in the late morning of July 29, 2005. In order to allow the parties sufficient time to prepare their prehearing statements, FRF requests that the time to file prehearing statements be extended by two days, until 5:00 P.M., August 3, 2005.


Counsel for FRF has contacted counsel for all parties of record, and is authorized to represent that all parties either actively support or do not oppose its Motion. Upon consideration, FRF's request is reasonable and its Motion is hereby granted.

Based on the foregoing, it is

ORDERED by Chairman Braulio L. Baez, as Prehearing Officer that the Florida Retail Federation's Unopposed Motion for Extension of Time to File Prehearing Statements is granted. It is further

ORDERED that the controlling dates established in Order No. PSC-05-0487-PCO-EI shall be revised to reflect that prehearing statements for all parties shall be filed on or before August 3, 2005. Order No. PSC-05-0487-PCO-EI is affirmed in all other respects.

NOTICE OF FURTHER PROCEEDINGS OR JUDICIAL REVIEW

The Florida Public Service Commission is required by Section 120.569(1), Florida Statutes, to notify parties of any administrative hearing or judicial review of Commission orders that is available under Sections 120.57 or 120.68, Florida Statutes, as well as the procedures and time limits that apply. This notice should not be construed to mean all requests for an administrative hearing or judicial review will be granted or result in the relief sought.

Mediation may be available on a case-by-case basis. If mediation is conducted, it does not affect a substantially interested person's right to a hearing.

Any party adversely affected by this order, which is preliminary, procedural or intermediate in nature, may request: (1) reconsideration within 10 days pursuant to Rule 25-22.0376, Florida Administrative Code; or (2) judicial review by the Florida Supreme Court, in the case of an electric, gas or telephone utility, or the First District Court of Appeal, in the case of a water or wastewater utility. A motion for reconsideration shall be filed with the Director, Division of the Commission Clerk and Administrative Services, in the form prescribed by Rule 25-22.060, Florida Administrative Code. Judicial review of a preliminary, procedural or intermediate ruling or order is available if review of the final action will not provide an adequate remedy. Such review may be requested from the appropriate court, as described above, pursuant to Rule 9.100, Florida Rules of Appellate Procedure.
